# Why the need for the Aqua Card?

- Drinking water service providers have clear public health responsibilities to customers.
- Those working on or around water infrastructure need to understand how their work can potentially increase the risks of contaminants entering the drinking water system.
- SEQ Joint Operations Committee was particularly concerned with the risk of a growing number of contractors with no understanding of water quality issues when working on water networks.
- Content development took time but included broad industry engagement and contributions which reinforced the need for the course.



# Aqua Card Overview


- The course is designed for employees of utilities and contractors involved in construction and maintenance activities on network assets. It covers:
  - What contaminants are, the risks they pose to the public and how they can enter a drinking water system
  - The responsibilities of those working on and around water infrastructure to reduce the risks of contaminants entering them
  - Practical guidance including good housekeeping and disinfection practices
- **qldwater** has commissioned development of a “Brown Card” (the wastewater equivalent of the Aqua Card) which we hope to release later in 2020.



# Accessing the Aqua Card

- Visit [www.watertraining.com.au](http://www.watertraining.com.au) (use Google Chrome and enable Cookies)
- Create an Account then click on the 'Aqua Card' tile
- Access is free for employees of **qldwater** and Water Skills Partnership members for internal use – contact [skills@qldwater.com.au](mailto:skills@qldwater.com.au) for the access code and enter it in the 'Enrolment Key' field
- Fee is \$50 including GST for non-**qldwater** members. These fees help cover ongoing hosting fees and costs for updates to the content.
- Discounts for bulk registrations by contractors are available to encourage maximum exposure to the content.

- The course will load, use the 'Next' button to progress through the slides

- A certificate will be issued on successful completion, valid for three years
